Tax changes for 2015/2016

From **6 April 2015** you can get your interest paid gross if your income for the tax year is **£15,600** or less.

Even if your total income is higher than **£15,600**, you may still be able to get back some of the tax you've paid on your interest.

For more information and to check if you're eligible to register for gross interest go to gov.uk/taxfreesavings.

If you're eligible, registering for gross interest is easy. Simply visit your local branch, call **0800 587 3344** or log on to Online Banking – you can manage this under the 'My Details & Settings' tab.

The above applies to you if you are a UK resident for tax purposes.

Completing a tax return

The **Account Summary** makes it simple to complete a tax return. It details the interest paid and tax deducted for your personal savings and current accounts.

Your Account Summary for the tax year **6 April 2014 to 5 April 2015** is available to view and print in Online Banking, simply select 'e-Documents' from the left-hand menu of the 'My Accounts & Transactions' tab.
